SOP for Bank Guarantee Management for Empanelled Rice Mills (Replacement of BG – Same Bank)



Date of Release: 14.01.24

A facility for empanelled Rice Mills to continue BGs from last KMS and enter new BGs is already live and functional. Now, the facility of replacing a BG that is going to expire, has been incorporated in the same module with the following workflow:

Rice Mill Login

1. The Rice Mill will do the work from 'Bank Guarantee' menu. Bank guarantees already entered into the system will be shown with all details including expiry date.

2. As such, the BGs approved by DCF&S and are due to expire in next 45 days will be available for replacement. A BG will cease to have its paddy holding limit value with 30 days to go for expiry. Already expired BGs cannot be replaced. However, since it is observed in the database that some BGs have expired since 02.01.25, all such BGs will be available for replacement. To start the process of replacement, the Rice Mill will click on the replace button in the concerned row. This pop-up screen will open. The IFSC, bank name, branch name, BG no., BG value and BG issue date will not be allowed to be changed.

- 9. On clicking the Rice Mill name in the previous step, details of all BGs submitted will open. The DCF&S can see all data of a BG including the newly entered expiry date, claim date and the newly uploaded BG document. He will either approve or reject a BG. If he selects 'Reject' in the 'Approve/Reject' button, he will have to select a reason from the drop-down list.
- 10. If the DCF&S wishes to approve the BG, he will select 'Approve' from the 'Approve/Reject' drop-down menu. In such case, remarks will be 'approved'.
