
Sir,



Sub.:- Enhance the district wise Paddy Procurement Target of PAMCL for Cooch Behar and Jalpaiguri districts and reduce the target of Bankura district for KMS 2023-24.

Sir,

With reference to the subject mentioned above, this is to inform that the performance of Bankura is not satisfactory whereas Cooch Behar and Jalpaiguri have almost achieved their target (copy enclosed). In fact these two District authorities have already requested us to enhance their target for this KMS.

Keeping these in mind, we may be allowed to enhance the procurement target of KMS 2023-24 for Cooch Behar and Jalpaiguri by 1000 MT each while that of Bankura be reduced by the same amount i.e. 2000 MT, thus leaving the overall target of PAMCL same i.e. 50000 MT.

Once allowed it would have been easier to achieve our overall target.
